#### CHRIS BONO

Entering his second year as head wrestling coach at South Dakota State, Chris Bono brings knowledge and success to the program. At the University of Tennessee at Chattanooga, Bono produced three Southern Conference titles, two All-Americans and 19 NCAA qualifiers.

Bono was named head coach at UTC on July 29, 2006 and wasted little time directing the Mocs to their 22nd Southern Conference championship. He coached 9 wrestlers to the 200 NCAA Championships, a feat matched only by Minnesota. During his 3 seasons, UTC scheduled many nationally ranked teams. Bono coached the Mocs to wins over Ohio State in 2009 and 2010; the Buckeyes were ranked No. 8 at the time of the second loss.

In his first season, Bono guided the Mocs to a 16-1 dual-match record, including an 11-match win streak to start the season and a victory at No. 14 Ohio State. He received high consideration for National Coach of the Year honors from RevWrestling.com.

Before joining the UTC staff, he served nine years as an assistant coach at Iowa State. He was the Cyclones' head assistant coach for five seasons. In Bono's final year on the ISU staff, the Cyclones earned a third-place finish in the Big 12 Conference and a sixth-place showing at the NCAA Championships.

A native of Gilbert, Iowa, Bono was named the National Wrestling Coaches Association Assistant Coach of the Year in 2002 for his role in ISU's success. Bono lettered at Iowa State from '94-'97

and ranks fifth on the program's all-time win list with 130 victories. He won the NCAA 150-pound title as a junior. A four-time NCAA participant, Bono placed fifth at the Nationals as a sophomore and second as a senior. As a freshman, he finished eighth at the Big Eight Conference Championship in 1997. He was 115-17 his final three seasons.



#### ISRAEL SILVA

Israel joined the SDSU wrestling coaching staff in the spring of 2012. He brought enthusiasm, intensity and international wrestling experience to the Jackrabbit program.

Silva served as an assistant coach at the Northwest Wrestling Regional Training Center in Corvallis, OR, for the past 3 years. He was a volunteer assistant under Bono at the University of Tennessee at Chattanooga for 3 seasons. He is a 4-time World Team Member for Mexico, 3-time Freestyle Pan American medalist and 2012 Olympic alternate over 7 years of international experience. Silva was a

2-time Junior College All-American at North Idaho College. He placed 2nd at the national tournament his sophomore year and was 3rd as a freshman. Silva led the team to the Junior College National Championship in 2002.

A native of Marysville, Wash., Silva was a 4-time state qualifier at Pilchuck High School. He captured the state title his junior season, finished as the state runner-up his senior year and placed 6th as a sophomore.
