Open: 5 dives Women; 6 dives Men – No DD limit
Synchro: Group C (13&U) 4 dives – 2 vols @ 2.0 DD and 2 Opts. Must use 4 groups
Group A/B (14-18) 5 dives – 2 vols @ 2.0 DD and 3 Opts. Must use 4 groups
- Entries: All entries are online at www.divemeets.com. Entry fee is \$30 PER EVENT. Late entries of \$15 will be accepted. **No entries or dive changes will be allowed less than 1 hour before the start of the event.**
- Awards: Top 12 divers per event will receive awards. 1-6th place medals; 7-12th ribbons.
- Practice: Pool and boards open at 6am, Saturday and Sunday. Boards close at 8am for first event. Meet starts at 8:30.
